ACCREDITATION BOARD

The Board is the highest decision-making body responsible for system-wide governance, policy approval, oversight of accreditation decisions, and standard compliance. It consists of representatives from all three alliances (ICA, IBTA, IWYA), as well as independent experts and senior advisors.
